Personal Return-to-Work Considerations

The COVID-19 shutdown started while colleges were releasing students on the annual Spring Break for a wellearned retreat from rigorous college life. Personally, I learned about the oncoming tidal wave of the national shutdown in the Atlanta airport on the way to meet my two PhD student daughters in Asheville, North Carolina. As the shutdown rolled through stateto-state, many of us were sent home to continue our jobs as telecommuters...as Safety/ES&H Professionals, many of us were identified as critical staff for supporting continued operation of essential business.

At some point, the current COVID isolation will be normalized, and employees will be returning to work—in some form or fashion. Business critical decisions for returning to work will necessitate input from Safety/ESH Professionals to help understand and implement the CDC's Interim Guidance for Businesses and **Employers Responding to**

Coronavirus Disease (COVID-19), May 2020

We may be asked to assist in a range of activities, ranging from the preparation of a Return-To-Work Plan to physically setting up an employee health monitoring process to help prevent the continued spread of the COVID-19 virus.

As we help, the human side of returning to work is an important consideration. As our coworkers return, consideration for everyone's experience during the past months should be on the forefront of our efforts. Some workers may be motivated to return to a "normal" work environment and move beyond the COVID-19 experience. Other workers may be hesitant to return to work for many reasons. Consideration for what our coworkers have dealt with over these months—from COVID-19 recovery or loss of a loved-one to loneliness from self-isolation or concern for their own health

upon returning to work. Even those workers motivated to return to work, anxiety over changes to the work environment necessitated in response to COVID-19 may occur. Many workers may have anxiety over health monitoring whereas others may have anxiety over social distancing in the work environment. And likely workers will continue to have anxiety over contracting COVID-19 upon return.

Consider developing your own philosophy as a leader in the workplace that involves management, supervisors, and workers—always treat workers with dignity and respect. You will need to have positive interactions with workers to help assure them of a safe work environment as they return to work. Our leadership will help redefine normalcy in the workplace and help workers return to work and businesses to reopen as smoothly as possible.
