2025 NM ASSP Professional Development Conference (PDC)

Our last NM ASSP Professional Development Conference (PDC) in 2024 was a success for our attendees. We had approximately 100 attendees who had an opportunity to participate in over 20 presentations and earning CEUs.

We partnered with two sister organizations as co-sponsors, which helped bolster funding for hosting the PDC. Both the New Mexico Society of Hazardous Materials Managers (NMSHMM) and the NM System Safety Society (NMSSS) helped to significantly fund the event.

Unfortunately, costs associated with hosting the PDC at the Sandia Casino Conference Center annually are greater than NM ASSP can afford. The NM ASSP Board has decided to host the PDC every two years – but still at the Sandia Casino Conference Center as requested numerous times by our members.

Our next PDC is slated for March 2026. The Board is also working on ways to increase our funding such as finding corporate sponsors, increasing our vendors, raising the attendance fee to reflect costs,

and improving our numbers of attendees. The Board also requests member input into planning the PDC as well as requests support for our NM ASSP organization. We continue to meet monthly and always need interesting speakers.
